

Taven of Rest's Harvest Home ▲ shelter for women and children is a festive place during the Christmas season. Women and their families are kept busy with special activities and events throughout the month of December like riding the Polar Express, going to see the Hower House in downtown Akron, and putting up Christmas decorations. The week before Christmas, Harvest Home Staff and volunteers host Christmas parties for the families and for the women staying without children. The women staying in the Women's Day Room are treated to a special Christmas brunch provided by a local Amish congregation, participate in a white elephant gift exchange, eat Christmas cookies, and hear the story of Christ's birth.

The moms and kids get to kick off their party with crafts and games like reindeer antler ring toss, pin the nose on the snowman, and Christmas charades. After supper and dessert, the Christmas Story is read and everyone receives Christmas gifts: toys for the kids, gift cards for the moms, and new pajamas for everyone! The party ends with singing "Joy to the World," reminding

everyone who attends that Jesus is the reason they gather in celebration.

In preparation for Christmas Day, moms are taken by staff to shop for gifts for their children provided by donors to the Mission. Last year while shopping, a woman excitedly told staff that she had never been able to provide such a nice Christmas for her children and could not wait until her children woke up Christmas morning to see what Mommy got them. Donors also give special attention to the women and coordinate with staff to see that the women wake up Christmas morning to thoughtful gifts of their own.

On Christmas Day, moms gather their kids around one of the Harvest Home Christmas trees to open gifts and everyone enjoys a traditional holiday meal of turkey, mashed potatoes, stuffing, and more made by the Haven of Rest Food Service team. It is a special, heart-warming day for women and their families who call the

CELEBRATING CHRISTMAS IN THE MEN'S DIVISION

esident men in the Conquerors Program enjoy two special events. The first event is the resident Christmas party, which takes place in the cheerfully decorated Community room. Men's Division staff share a devotional and a Gospel message, lead in singing Christmas carols, and provide the opportunity for residents to share how this Christmas is different and what they like about it. After a white elephant gift exchange game, each of the men are surprised with a large bag full of gifts that have been donated and wrapped by volunteers. These items often include study Bibles, devotionals, grooming kits, watches, wallets, gift cards, blankets, etc.

The second event is a delectable Christmas feast. Male staff prepare to join the resident men for this dinner later in the evening. The dinner may take place at a restaurant, or they can have it catered to relish in the Community room. Good fellowship is enjoyed by the men as they share stories, encourage one another, and listen to Christmas music.

Haven of Rest also provides an opportunity for resident men to shop for their spouses and children prior to these two events. After they choose the gifts they believe their families will enjoy, they are assisted in mailing them to their families in time for Christmas. Many of these men have not been able to send gifts to their families for a long time, due to their life controlling issues. So needless to say, this comes as a special surprise! Sometimes giving a gift creates an opportunity for the men to restore relationships with family and friends. In the midst of their many difficulties, this gesture towards their loved ones often provides hope and a blessed Christmas.

THE BASICS OF RMDS

"On behalf of the board of trustees, we wish you a blessed Christmas and a big impactful New Year."

WHAT ARE RMDS? - A required minimum distribution (RMD) is the minimum amount of money that must be withdrawn from certain retirement savings accounts each year after a specific age. Typically, these distributions are subject to income tax.

WHO DO RMDS APPLY TO? - RMDs most commonly apply to the following types of retirement savings accounts: Traditional IRA, 401(k), 403(b), 457(b), SEP IRA, SIMPLE IRA, and other defined contribution plans. Roth IRAs are not in this list because the IRS does not require you to take withdrawals from Roth IRAs while you're alive. Your beneficiaries may have to take RMDs after your passing, however.

WHEN DO YOU BEGIN TAKING RMDS? - Due to the passing of the SECURE act in 2020, there are different ages you may have to begin taking RMDs. For anyone who turns 70 ½ after January 1, 2020, you do not need to begin taking RMDs until you turn 72. Your first RMD must be withdrawn by April 1 of the year after you reach 72. For each of the following years, you must take your next RMD by December 31 of each year. If you turned 70½ before January 1, 2020, you've already begun taking RMDs. The IRS does not take missing RMDs lightly and could hit you with a penalty as big as 50% of the RMD amount that was not withdrawn. For these reasons, it is certainly a good idea to get help from a financial advisor or tax professional who can help you with your specific situation.
